

STANDARD WARRANTY POLICY

Effective With Deliveries to the First User On or After March 1, 2006



Mega Corp. warrants its products against defects in material and workmanship for a period of 12 months from the time the unit is first placed into service unless stated otherwise below.

Mega Corp. does not warrant malfunctions and failures resulting from misuse, negligence, alteration, accident, or lack of performance of regular maintenance services, nor does it include the replacement of maintenance items made in connection with normal maintenance services. In addition, travel mileage, travel labor, or related travel expenses (such as meals or lodging) will not be covered.

Mega Corp. requires the customer/owner to complete the In-Service report and return it to Mega Corp. within 30 (thirty) days from the date the machine is placed into service.

This warranty becomes null and void when the product is disassembled, welded-upon, or in any way materially altered without prior written approval from Mega Corp.

Items replaced under this warranty become the property of Mega Corp. All items replaced must be returned to Mega Corp., freight pre-paid.

Responsibilities

Mega Corp. Responsibilities

If a defect in material or workmanship is found during the warranty period, Mega Corp. will:

- Provide (at Mega Corp.'s discretion) new, remanufactured or Mega Corp.- approved repaired parts or assembled components needed to correct the defect.
- Replace lubricating oil, filters, anti-freeze and other items made unusable by the defect.
- Provide reasonable or customary labor needed to correct the defect, including labor for removal and installation when necessary to make the repair.

User/Customer Responsibilities

The user/customer is responsible for:

- · Contacting Mega Corp. for authorization prior to the
- Providing Proof of the Delivery Date (via the In-Service Report) to Mega Corp.
- The cost associated with transporting the product or warranty item to the place of repair.
- Costs to investigate complaints, unless the problem is caused by a defect in Mega Corp. materials or workmanship.
 - Labor costs except as stated under "Mega Corp Responsibilities".
- Premium or overtime labor costs.
- Local taxes, if applicable.
- Giving timely notice of a warrantable failure and promptly making the product available for repair.
- Performance of required maintenance and items replaced due to normal wear.
 - Allowing Mega Corp access to any electronically-stored data relevant to the warranted product's application.

Special Coverage Limitations Structural Fallure

Structural failures are described as:

- Cracking in weld or base metal of structure not caused by damage or abuse.
 - · Water leaks from tanks due to cracking or weld defect.

Kits For Field Installation

Mega products provided in kit form are designed for field assembly/installation and are covered under the terms of this warranty with the following provisions:

- Installation Mega Corp. will provide a basic set of drawings for use with installation of products delivered in kit form. These drawings are intended to assist the dealer / customer with installation. Mega Corp. Product Support may be contacted for additional assistance if required. Charges may apply for this service.
 - Parts Mega Corp. guarantees that all Mega-supplied parts required for field installation will be in the field installation parts kit. There may be parts that are expected to be supplied by the customer to complete installation. Mega Corp.—supplied parts will be detailed on the installation drawings. Packing lists are supplied with all kits. The customer is responsible for notifying Mega Corp. of missing or damaged parts upon receipt. Signed copies of the packing lists confirming receipt of all parts must be returned to Mega Corp. within 14 days of receipt of parts to maintain this coverage.
